Responsive invoices are provided with redactions to protect confidential and exempt information. Redactions are limited to personal identifying data, account numbers, and nonpublic security information under § 708(b)(6) and § 708(b)(3).

All invoices fall within the allowable public financial documentation of this Office.

2. Bank Statements and Payment Confirmations:

Responsive bank statements related to the Automation Fund and other approved expenditures are provided with redactions.

Redactions have been applied to remove banking institution account numbers, routing information, and internal identifiers in compliance with § 708(b)(6).

These records confirm disbursements and deposits related to official Recorder of Deeds operations.

3. Checks and Payment Records:

Copies of checks and payment records in the possession of this Office are provided with redactions to remove financial account data, routing numbers, and personal identifiers under § 708(b)(6).

Any records not provided do not exist in the possession, custody, or control of this Office.

4. Contracts and Agreements:

Responsive contracts and vendor agreements corresponding to the invoices and payments listed above are provided with redactions to protect personal identifying and privileged information under § 708(b)(6) and § 708(b)(10)(i)(A).
